MESSAGE FROM THE CHAIRMAN



Dear EU-ABC members, partners and colleagues,

First, allow me to wish each of you a Happy New Year and a prosperous and healthy 2020.

We started last year with daily news of financial market volatility, US-China trade tension, China's transition to a slower growth trajectory, and worries about "hard Brexit" —and ASEAN as a region of comparative stability. We enter 2020 with stock markets in an uptrend, somewhat better news on US-China and Brexit having entered a new phase (with still many uncertainties to be resolved). As we entered the Chinese New Year holidays, however, uncertainty came back with the outbreak of the new coronavirus in Hubei. We must be vigilant, and assist however possible the efforts in China and internationally to contain the spread.

ASEAN growth slowed a bit in 2019, but, in the views, European business, ASEAN remains the region of greatest opportunity by almost two to one. With 88% of European businesses planning to expand trade and investment in ASEAN, the Business Council's most important objective is to help create a positive business environment to help make that possible. A recent survey ("The State of Southeast Asia: 2020") of ASEAN citizens rank Europe as the second most trusted partner to "do the right thing" to contribute to global peace, security, prosperity and governance (Japan was #1, US #3, and China and India tied at #4). It behoves all of us to live up to those expectations of trust by delivering talent, innovation, IP, jobs, investment and sustainable business models that lead to shared prosperity and progress toward the Sustainable Development Goals.

This year the EU-ABC will continue to engage with ASEAN bodies, ASEAN member states, the European Commission, and other key organisations and I urge all members to be active and be heard. There are many opportunities to get involved. I draw your attention in particular to the following key events and dates in the first half of 2020

 -ASEAN Customs Directors General Meeting: 10-12 June, Nay Pyi Taw

In addition please be on the lookout for announcements of other events and programs.

Later in 2020 we will organise several other Trade and Investment missions and also the 8th EU-ASEAN Business Summit in September.

Work is also underway on the development of a position papers on healthcare and life sciences, financial services, automotive and digital economy sectors, as well as papers on trade facilitation & customs issues and sustainability issues. We invite all of our members to play an active role in developing positions on these topics, and in proposing new ones.

A truly engaging and informative session where attendees gained valueable insights on how to successfully undertake market entry from a legal perspective to four of the fastest growing economies in the region.



The EU-ABC attend the 16^{th} edition of the ASEAN Trade Facilitation Joint Consultative Committee (ATF-JCC) held by the Ministry of Industry and Trade (MoIT) in Hanoi on 9-10 January 2020. It is the first meeting organised by MoIT since Vietnam took over ASEAN Chairmanship from Thailand.

Areas covered in the meeting included cooperation in facilitating intra-ASEAN trade, initiatives on simplifying customs procedures with the aim of reducing 10 percent of trading cost within the bloc in 2020 and also touched on the establishing a mechanism for exchanging information about NTMs, the increase of consultation between ASEAN governments and the business community. A proposal for regulatory impact assessment of NTMs was also discussed.

High-Level Symposium on Enhancing Intra-ASEAN Trade and Investment for a Cohesive and Responsive ASEAN

Roundtable Discussion on Non-Tariff Barriers (NTBs) in ASEAN between the Private Sector and the ATF-JCC








On 22nd January in Bangkok, the EU-ABC, with assistance from the EU's ARISE+ project, and in collaboration with ASEAN BAC, organised a roundtable discussion with key ASEAN officials on moves to eliminate Non-Tariff Barriers in ASEAN.

The Roundtable followed on from the publication in June 2019 by the EU-ABC and ASEAN BAC or their joint report on Non-Tariff Barriers in the region (see: here) and provided a valuable platform for senior trade officials from ASEAN Member States and the private sector to exchange views and ideas on how to make faster progress on this key issue.

The Roundtable was addressed by the current Chair of the Co-ordinating Committee for ATIGA, Kejpiroon Kate Kohsuwan of the Ministry of Commerce in Thailand, and also from the author of the original report, Deborah Elms of the Asian Trade Centre."
