MESSAGE FROM THE CHAIRMAN



Dear EU-ABC members, partners and colleagues,

First, allow me to wish each of you a Healthy and Fruitful 2021. I think most of us have never been as ready as we were in late 2020 to usher in a new year, and for many, 2020 was a “year to forget”— managing the challenges that COVID-19 presented to our businesses, plus the additional stress of working from home (or “living at work?”), being quarantined, and mourning the tragic loss of friends or colleagues. There is much we would like to leave behind from 2020 and re-boot to “normal”. But alas, we will need to be resilient again, perhaps for most of this year, and find ways to adapt, seize opportunities and bring our best efforts to the customers, employees, partners and communities in which we work.

Like our members, the EU-ABC adapted quickly to a COVID-restricted world in 2020. Thanks to the creativity and hard work of our ED Chris Humphrey and his key teammates Shangari Kiruppalini and Angeline Kwek, the Business Council shifted to virtual format — webinar meetings with ASEAN Ministers and working groups, virtual trade and investment missions, an expanded slate of webinars and programmes (26 from March) and position papers (11 in the year). All of that was capped off in November by our successful first “hybrid” ASEAN-BU Business Summit in Singapore and virtually. Thanks to the enthusiastic support from our members, those initiatives allowed us to maintain momentum on the key themes of economic integration, digital commerce and trade, sustainability (finance, investment and health), and reducing barriers to trade and investment. We were also able to finish the year in good financial shape, which allowed us to offer discounted dues to our members for renewals.

The year will undoubtedly hold some surprises as the world navigates vaccinations and re-openings, as the US and China deal with trade tension, and as governments face rising fiscal burdens. I am optimistic, however, that the opportunities for European business to thrive and help ASEAN achieve its vision are as great as ever. Our 2020 Business Sentiment Survey again confirmed that over half of European businesses see ASEAN as the region with the best economic opportunity.

I urge all members to be active and be heard as we reach out to ASEAN bodies, ASEAN member states, the European Commission, and other key organisations. The Business Council’s most important objective is to work with members, other Business Councils, and governments to foster an environment for trade and investment, for delivering talent and innovation, for creating and protecting IP and jobs, and for doing all that in a way that is environmentally and socially sustainable. We invite all of our members to play an active role in developing positions on those topics, and in proposing new ones, and in helping to deliver the message coherently and with commitment. We have already had meetings this month with Indonesia’s Director-General for Customs (6 Jan), Ramon Lopez, Philippine’s Secretary for Trade and Industry (19 Jan), Malaysia’s Minister for Finance (25 Jan) and held a roundtable with the EU Ambassador to ASEAN (18 Jan). Please look for other scheduled meetings/programmes and opportunities to engage, including a range of meetings with various ministers from Indonesia in early February.

Work is also underway on the development of a position papers on Trade Facilitation and Customs issues, Emission and Fuel Standards for the Automotive Sector, and on Healthy Aging in ASEAN. In addition, we are exploring how to further engage on financing sustainable development — which could involve many sectors in which our members engage, and looking into developing positions in other sustainability related areas such as Energy Transition and Efficiency, and Plastic waste.

2. TAX ID AS REQUIREMENTS/ MANDATORY TO BE WRITTEN IN BILL OF LADING OR MANIFEST

MAIN PURPOSE:

- Compliance:** To improve the level of taxpayer compliance.
- Improving public service:**
 - To ease the transshipment process by automatically reconcile the inward and outward manifest.
 - To help identifying the real importer to get notice of arrival.

MAJOR ISSUES:

- MANDATORY TAX ID FOR INVOICING AND POST since 2017
- MANDATORY TAX ID FOR INWARD/OUTWARD MANIFEST

REAL SHIPPER: 01 AUGUST 2023 (Mandatory Tax ID for Real consignee and shipper)

Countries that already using tax id in import document or bill:

- Mexico (2010)
- China (2018)
- Turki (2012)
- USA (2008)
- Brasil (2017)
- Japan (2014)

Note: Prior to mandatory implementation, private sector can use passport number, national ID number, or other ID

- Improving the management of the Special Economic Zone would promote more competitive investment climate and conducive business environment

ONLINE SINGLE SUBMISSION

- Online single submission becomes one of feature in the National Logistic Ecosystem which is being developed.
- The NLE would eliminate duplication and repetition processes in logistics related public services by collaborating government and private institutions' system.

RCEP

- Use of e-COO which would expedite the verification process.
- Preparation of legal basis for the implementation of advance ruling on origin and post importation claims for preferential tariff.


Meeting with Secretary Ramon Lopez, Department of Trade and Industry, Philippines

Webinar – ASEAN in 2021: Prospects and Challenges



The webinar discussed the key prospects and challenges for ASEAN in 2021 within the context of the COVID-19 pandemic.

The key takeaways are:

- There is optimism for ASEAN's strong economic recovery and competitiveness as a production base in 2021 because of RCEP's potential, the China +1 supply chain strategy, boom in semiconductor demand due to WFH requirements, investment opportunities for electric vehicle production, and a concerted effort by ASEAN governments to attract FDI through domestic institutional reforms.
- However, challenges include fiscal deficits due to COVID-19 stimulus packages, labour shortages due to COVID-19 cases, delayed economic recovery caused by new COVID-19 outbreaks, with herd immunity expected to be achieved in 2022 via vaccination.
- The ASEAN Member States must understand that promoting regional vaccination is of each members' national interests and vaccine-nationalism must be avoided.



UPDATE: DATA GOVERNANCE REPORT



As background, the EU-ASEAN Business Council supported Vietnam's Chairmanship by publishing a [Data Governance Report](#) to help lay the groundwork for ASEAN's data governance work last year. The report outlines how ASEAN leaders can approach the issue of data governance at a time when cross border data flows are becoming key economic drivers.

We are pleased to share that the ASEAN Data Management Framework (DMF), which was approved on 22 January, accepted the Council's recommendations listed in the Data Governance Report. The accepted recommendations are: (1) to use EU-ABC proposed ISO standards; and (2) to adopt a whole of data lifecycle approach.

We will continue to work closely with ASEAN leaders on Data Governance, especially on how they can adapt and adopt GDPR elements into their laws. The EU-ASEAN Business Council is pleased that the ASEAN leaders share our view that the DMF is an important tool that stresses a full data lifecycle framework to uphold data accountability.


